In terms of Section 53 of Major Port Authorities Act, 2021, Ministry of Ports, Shipping & Waterways (MoPSW) has directed Major Port Authorities to consider fixing tariff of existing Terminal operators / PPP concessionaires who were governed by 2005 and 2019 Tariff Guidelines of Tariff Authority for Major Ports (TAMP).

2. Validity of Scale of Rates of existing BOT operator International Seaports (Haldia) Private Limited (ISHPL) has expired on May 05, 2025. ISHPL has requested port to extend the validity of their Scale of rates vide letter dated January 08, 2025.

3. Presently there are no Tariff Guidelines for fixation of tariff of existing BOT operators governed by erstwhile Tariff Guidelines of 2005 & 2019 issued by TAMP. It may be mentioned that Ministry has prepared Draft Migration of Tariff Guidelines, 2024, for Adoption of Market Determined Tariff of existing PPP projects who are governed under Guidelines for Regulation of Tariff 2005, 2008, 2013 and 2019 and invited comments from the stakeholders, experts and general public on the said Draft Guidelines vide letter Dated September 26, 2024. However, the said Draft Guidelines are yet to be finalized and notified by Ministry. In absence of such guidelines neither the BOT Operators are in a position to submit their proposal for tariff fixation nor port is in a position to examine and fix the tariff proposal.

4. As there cannot be void in the tariff validity, the proposal of ISHPL for extension of their Scale of rates is required to be considered by port.

5. Accordingly, in exercise of power conferred under section 27 of Major Port Authorities Act 2021 as well as direction given by MoPSW in this regard under section 53 of the said Act, the Board of Syama Prasad Mookerjee Port, Kolkata (SMPA), based on application of ISHPL, hereby extends the validity of their existing Scale of Rates for a period of one year with effect from May 6th, 2025 with indexation benefit, as applicable, or till their new Scale of Rates comes into force whichever is earlier vide Resolution No. R/24/HDC/FIN/3/01/2025 Dated January 31, 2025.

6. ISHPL may note that the rates prescribed in their Scale of Rates are ceiling level; like-wise the rebates and discounts prescribed therein are floor levels. ISHPL may, if it so desires, charge lower rates and/ or allow higher rebates and discounts.

महा पत्तन प्राधिकरण अधिनियम, 2021 की धारा 53 के अनुसार, पत्तन, पोत परिवहन और जलमार्ग मंत्रालय (एमओपीएसडब्ल्यू) ने महापत्तन प्राधिकरणों को मौजूदा टर्मिनल संचालकों/पीपीपी रियायतग्राहियों के लिए टैरिफ तय करने पर विचार करने का निर्देश दिया है, जो महापत्तन के लिए टैरिफ प्राधिकरण (टीएमपी) के 2005 और 2019 के टैरिफ दिशानिर्देशों द्वारा शासित थे।

2. मौजूदा बीओटी ऑपरेटर इंटरनेशनल सीपोर्ट्स (हल्दिया) प्राइवेट लिमिटेड (आईएसएचपीएल) के दरमान की वैधता 5 मई, 2025 को समाप्त हुई। आईएसएचपीएल ने 8 जनवरी, 2025 के पत्र के माध्यम से पत्तन से अपने दरों के पैमाने की वैधता को बढ़ाने का अनुरोध किया है।

3. वर्तमान में टीएमपी द्वारा जारी 2005 और 2019 के पूर्ववर्ती टैरिफ दिशानिर्देशों द्वारा शासित मौजूदा बीओटी ऑपरेटरों के टैरिफ निर्धारण के लिए कोई टैरिफ दिशानिर्देश नहीं हैं। उल्लेखनीय है कि मंत्रालय ने मौजूदा पीपीपी परियोजनाओं, जो टैरिफ विनियमन दिशानिर्देश 2005, 2008, 2013 और 2019 के अंतर्गत शासित हैं, के बाजार निर्धारित टैरिफ को अपनाने के लिए टैरिफ दिशानिर्देश, 2024 का मसौदा प्रवासन तैयार किया है और 26 सितंबर, 2024 के पत्र के माध्यम से उक्त मसौदा दिशानिर्देशों पर हितधारकों, विशेषज्ञों और आम जनता से टिप्पणियां आमंत्रित की हैं। हालांकि, उक्त मसौदा दिशानिर्देशों को मंत्रालय द्वारा अभी अंतिम रूप दिया जाना और अधिसूचित किया जाना बाकी है। ऐसे दिशानिर्देशों के अभाव में न तो बीओटी ऑपरेटर टैरिफ निर्धारण के लिए अपना प्रस्ताव प्रस्तुत करने की स्थिति में हैं और न ही पत्तन टैरिफ प्रस्ताव की जांच और निर्धारण करने की स्थिति में है।

4. चूंकि टैरिफ वैधता शून्य नहीं हो सकती, इसलिए आईएसएचपीएल के अपने दरों के पैमाने के विस्तार के प्रस्ताव पर पत्तन द्वारा विचार किया जाना आवश्यक है।

5. तदनुसार, महापत्तन प्राधिकरण अधिनियम 2021 की धारा 27 के तहत प्रदत्त शक्ति के साथ-साथ उक्त अधिनियम की धारा 53 के तहत पत्तन, पोत परिवहन और जलमार्ग मंत्रालय द्वारा दिए गए निर्देश के तहत, श्यामा प्रसाद मुखर्जी पोर्ट, कोलकाता (एसएमपीके) बोर्ड, आईएसएचपीएल के आवेदन के आधार पर, एतद्वारा अपने मौजूदा दरमान की वैधता को 6 मई, 2025 से एक वर्ष की अवधि के लिए, लागू होने वाले इंडेक्सेशन लाभ के साथ, या उनके नए दरों के पैमाने के लागू होने तक, जो भी पहले हो, संकल्प संख्या R/24/HDC/FIN/3/01/2025 दिनांक 31 जनवरी, 2025 के तहत बढ़ाता है।
