In exercise of the powers conferred under Section 27 of the Major Port Authorities Act 2021, the Board of Major Port Authority of Syama Prasad Mookerjee Port, Kolkata (SMPK), in its meeting held on 25.04.2024, approved the following modifications in the Short Term Licence Allotment policy, referred under Notes 3 of Section 18.1 of Scale of Rates of Kolkata Dock System (KDS) of SMPK, notified in the Kolkata Gazette Extraordinary on 30.09.2023, for transit storage of dry bulk/break bulk cargo, which is to be read as –

- a. The initial licence will be allocated for 30 days.
- b. However, the licensee may quit the license and handover the licensed premises, in part or in full, to SMPK, at the end of 10 or 20 days with 3 working days' notice in advance. If, the licensee desires to quit a licence before 10 days or in between 10-20 days or in between 20-30 days, the licence fee will be charged for 10 days, 20 days and 30 days, respectively.
- c. The licence fee and electricity charges for unused period and handed over portion will be refunded on proportionate basis to the Port Deposit Account of the licensee.
- d. Such handover will be applicable only during the licence period and not beyond it.

Pursuant to Section 27 of the Major Port Authorities Act, 2021 read with Clause 6(2) of the Major Port Authorities (Fixation and Implementation of Scale of Rates, Fees, and Conditions) Rules, 2021, the amendments pertaining to Notes 3 of Section 18.1 of Scale of Rates dated 30.09.2023, are being notified for information.
